Conformance status

It defines three levels of conformance: Level A, Level AA, and Level AAA. Chicks Ahoy Farm is partially conformant with WCAG 2.1 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.

Known limitations for Chicks Ahoy Farm:

1. **It can be difficult for our seniors and people with challenges to walk our farm spaces:** Because our farmland can be undeveloped, wet and sometimes flooded, it can be difficult to navigate for folks with disabilities and families with small children. We have placed pallets in places to provide temporary walkways. We are also applying for exceptions with municipal bodies in order to repair or mitigate the flooding in the wetlands.
